## PALATINE HIGH SCHOOL STUDENT PARKING REGULATIONS

(Please read carefully before signing)

- 1. All vehicles (including motorcycles) parked on school property must be registered with Palatine High School and display a valid Palatine High School or District 211 parking permit.
- 2. Visitors must park in the designated Visitor's area and be signed in at the main entrance desk. Students are not allowed to park in visitor parking at anytime.
- 3. Palatine High School assumes no liability for any damage, theft, injury or death resulting from a student driving to or from school or parking on school property.
- 4. School authorities or parents may suspend or revoke parking privileges at any time. In such cases, parking permit permits will be confiscated and fees forfeited.
- 5. By signing this Parking Permit Application I am consenting to the possible search of this vehicle while on school property if there is a reasonable suspicion that a search will reveal contraband or items inherently threatening to health and/or safety.
- 6. Violation of school regulations, local, state or federal laws may result in school disciplinary and/or law enforcement action. Lot specific violations include:
  - a. Possession or use of liquor or drugs on school property is strictly prohibited.
  - b. Possession of any weapon or hazardous material.
  - c. Disobeying the instructions of any staff member, <u>including written warnings</u> concerning any parking violations.
  - d. Smoking, in or out of the vehicle, is prohibited.
  - e. Use of cell phone by the driver with the vehicle in motion.
  - f. Speeding (excess of 10mph), reckless driving or disobeying traffic control devices.
  - g. Parked anywhere on school property without <u>DISPLAYING</u> a valid Palatine High School parking permit for that area.
    - i. Permits must hang from the interior rearview mirror with the number clearly visible through the front windshield.
    - ii. Possessing a permit but not displaying it is a violation.
  - h. Parked in Visitor, Staff, Handicapped or Reserved areas without authorization
  - i. Parked in any lot other than the one for which the permit was issued.
  - j. Parked at a yellow painted curb, in a painted striped area or fire or bus lane.
  - k. Driving in (including picking up and dropping off) the driveways closest to the building on the south or west side of the school building.
  - 1. Loitering in the parking lot -in or out of the vehicle.
  - m. A limited number of parking permits are available for each of the student lots. Students should apply as soon as availability is announced. The permit application (other side of this form) must be filled out completely and signed by the student and parent/guardian. <a href="Permits will not be issued">Permits will not be issued without a valid driver's license, proof of insurance, complete vehicle information including license plate number and fee (Preferred Permit only.)</a>
    - i. <u>PREFERRED PARKING</u> –MAIN LOT (fee required) first lot south of the school building, immediately to the south of the faculty parking area marked by a white line the length of the lot east to west. **If there are no spaces in the Main Lot, students should park in the Stadium Lot.**
    - ii. **STADIUM LOT ONLY** (free) fenced area next to the stadium may <u>NOT</u> park <u>anywhere</u> <u>else on campus</u> unless *specifically authorized!*
- 7. A \$5.00 fee will be charged to replace permits. NO EXCEPTIONS!
- 8. Village of Palatine Ordinance #18-81-18 (by permit only)
  - a. Plate registered, but no permit displayed = Warning "No Permit Displayed"
  - b. Plate not registered plus no permit displayed = Ticket "No Permit"
  - c. Permit displayed but plate not registered = Ticket "Vehicle not Register to Permit #"
  - d. Plate registered to a different lot Ticket "XXXX permit not valid in Lot"
