Dear Parent:

Recently, the United States Food and Drug Administration approved use of the Pfizer COVID-19 vaccine in individuals 12 years and older. District 211 is pleased to offer an opportunity for families to have their school-aged children vaccinated against COVID-19. In partnership with Jewel-Osco and School District 15, High School District 211 will host a vaccination event at **Palatine High School on Thursday, May 20 between 1:00 p.m. and 7:00 p.m.** Palatine High School is located at 1111 N. Rohlwing Rd., in Palatine. ***This vaccination event is for District 211 community school-aged students, 12 years and older.***

Anyone receiving the first dose of the vaccine on May 20 will be automatically scheduled for the 2nd dose of the Pfizer vaccine on **Thursday, June 10**. The 2nd dose administration also will take place at Palatine High School and the appointment time will be the same as the 1st dose. **Please ONLY sign up if your child is able to be present for both the 1st and 2nd dose dates.**

Parents should accompany their child. Any students under the age of 18-years-of age must provide a completed and signed parent/legal guardian [consent form](#) for immunization. The consent form and information on the Pfizer vaccine is included with this communication.

### **Additional Information**

- Jewel-Osco cannot guarantee a 2nd dose if the recipient is not available both days
- Please bring copies of parent ID and insurance, it is preferred that all materials be paperclipped together for Jewel-Osco's processing. Individuals will not be turned away for lack of insurance
- Vaccine recipients should wear vaccine appropriate clothes (short sleeves) to expedite the process
- All vaccination appointments will be held in the auxiliary gymnasium at Palatine High School. Parking will be available in the south lot and guests are asked to enter the building using Entrance 8
- Vaccination appointments are limited

If community interest is high and another opportunity presents, we will consider hosting additional vaccination clinics. We will continue to post information about other community-based vaccination opportunities on our websites and social media pages. District 211 is committed to supporting our families as we collectively work toward a full return to normalcy and a healthy community.
