Welcome to AP Language and Composition! In this class, you will grow as a thinker, reader, and writer. We have created a summer reading assignment to help you succeed in the class and on the AP test.

Part I: Devil's Highway Rhetorical Analysis Triple-Entry Journal

Assignment 1: Read and annotate the book.

Assignment 2: Complete the attached Triple-Entry Journal chart for *Devil's Highway*. You will have ten total entries. For each entry, you will need to do the following:

- 1) In the first column, write down an <u>important quote</u> from the text and cite it in MLA format, i.e. "Quote from the text" (Urrea #). Important quotes are quotes which are either rich stylistically, make a significant point or argument, provide evidence for a previously-given argument, question a different idea or statement, etc.
- 2) In the second column, explain what the <u>intended impact</u> of that quote on the target audience is. In other words, what is the author trying to make the audience think, feel, or do as a result of this quote?
- 3) In the third column, write down a <u>reflection</u> on the quote. You can do so by: connecting to another passage or quote from the text; connecting to real-world experience, news, or events; extending the argument within the passage; or by posing a question that the passage induces--be sure to posit an answer, though.

**Be sure to type your responses directly into the chart, print it out, and bring it to class on the first day after summer break.

(Continued on next page) Part II: The Crucible Argumentative Essays (2)

Assignment 1: Read and annotate the book.

Essay Prompt 1: In Arthur Miller's *The Crucible*, Reverend Hale tells Elizabeth Proctor that "no principle, however glorious" is worth dying for, and he argues that it is better to give a false confession than to die for a principle of belief.

Write an essay where you defend or refute Hale's assertion using evidence from *The Crucible* to support your stance. Use multiple pieces of evidence from the text. (note: Your argument should be central. This is not an analysis essay. You are using the text to make an argument).

Essay Prompt 2: Choose one character from *The Crucible*. Then, write an essay in which you argue whether that character's actions throughout the drama are selfish or sacrificial. Is the character a hero or villain?

Use multiple pieces of evidence from the text. (note: Your argument should be central. This is not an analysis essay. You are using the text to make an argument).

Essay Requirements

Your essays must

- □ Be about 1.5 pages (MLA Format, Double Spaced, TNR, 12 pt. Font, etc).
- Contain a brief introduction that ends with a thesis that fully answers the prompt
 Introduction should introduce the reader to the topic.
 - Introduction does not have to cover all of human history.
- Two ACEDIT paragraphs
 - Since your argument is central be careful that your deconstruct and impact are focused on making a claim
 - Don't just analyze
- A conclusion

Sample: "In Arizona, critics are more direct Toxic materials appear in jugs that looks like drinking water. Humane Borders' water stations are vandalized, the 300-gallon tanks broken open so the run dry. Small groups of Mexicans are found tied and shot in the head. The Border Patrol is sentimental, though, and they keep building towers" (214).	Sample: Urrea details the opposition to life-saving measures that USBP and other groups have put into place. Juxtaposing the cruelty of lay people against the mercy of the professional Border Patrol members, causes the readers to sympathize with the "illegal immigrants" and those who seek to help them. Despite the paradox/irony, the authorities seek to protect the "illegals."	Sample: The fact that there are groups who go out of their way to sabotage efforts to save the lives of "walkers" is sickening. While crossing the border illegally is wrong, it is encouraging that there are people and groups who work to help save lives. Malicious acts to disrupt or damage the aid resources only serves to harm and kill poor people. But it will not stop the flow of illegal immigration.
