The Board of Education entered executive session at 6:31 p.m. and resumed its meeting at 7:30 p.m.

"Those Who Excel"

Superintendent Small made the following comments:

"Each year, the Illinois State Board of Education sponsors the "Those Who Excel" awards to honor individuals who have made significant contributions to our public schools throughout the state.

Tonight, each school's principal as well as the program directors join me as we proudly recognize District 211 individuals who have been honored for their professional contributions, leadership, and community service. Each "Those Who Excel" award recipient will receive a crystal apple, similar to the one I have displayed here. When I call your name, please stand so you can be recognized.

Our first award winners are in the Team category. Members of the Alternative Learning Academy (ALA), please stand when I call your name. Administrator Dane Henning was named an assistant principal at Conant High School this year, but last year he was the lead administrator at ALA; Counselor Zoilita Herrera-Pytlewski; Social Worker Alexandra Fliess (Alex is unable to attend this evening); Mathematics Teacher Carly Sutherland; Science Teacher Joseph Macnider; English Teacher Sean Keevin; Social Studies Teacher Jordan Sandberg (Jordan is now teaching social studies at Schaumburg High School); and Teacher Assistant Moises Enciso.

The Alternative Learning Academy, also known as ALA, has been an integral part of District 211 since 2016 and was designed to provide a District-operated alternative education program for students in need of more thorough and comprehensive support. The ALA, located in the District 211 North Campus building, has been described by a parent as a team 'in touch with us and our needs.' A fellow teacher noted that the ALA had 'executed their duties and demonstrated excellence by returning a significant number of students to their home schools and guiding others to a successful graduation.' The ALA team's dedication and care for our students in need is a shining example of caring and compassionate in education. Thank you all for believing in our students and all that you do for them within District 211.

Our next awardee is Schaumburg High School Psychologist Pamela Enright. Pam is recognized in the "Those Who Excel" Student Support Personnel category. An administrator at Schaumburg High School described Pam as their 'go to' person when students have found themselves in at-risk situations or activities. Pam's peers have said that 'even in the most demanding of circumstances, she demonstrates extraordinary patience, amazing follow through, and goes to the greatest lengths to ensure students and parents are aware of their choices.' Pam works on the school's Life and Learning Strategies Team to assist students with a variety of disabilities. Outside of Schaumburg High School, Pam works with her colleagues across the District to build initiatives to help at-risk students and she had a vital role in the creation of the District's social-emotional threat assessments. Thank you, Pam, for your dedication to our students' well-being and emotional health. Congratulations.

Our next awardee is Hoffman Estates High School Special Education Teacher Katie McGarvey, who was recognized in the Early Career Educator category. Katie comes from a family of teachers who nurtured her desire to enter education. Following a college course in special education, Katie noticed students with special needs were not getting the assistance they needed to be fully successful in class. From that point forward, she changed her major to special education and dedicated herself to do all she

could to give every student the tools needed to be successful in any class. One parent described Katie's compassion for education as 'contagious.' The parent went on to say that during the current pandemic, Katie's inspiration has only shown through more. The parent said, 'Katie treats each student like her own child.' One of Katie's peers discussed how, in only two years at Hoffman Estates High School, Katie has volunteered throughout the community to aid the Special Education department in coaching Special Olympics and taking on leadership roles in the school's annual Cupcakes with Friends fundraising event.

As part of this year's Teacher of the Year awards, Illinois has added a new, ancillary category within the Early Career Educator category, including Special Education Teacher of the Year. We are pleased to announce that Katie McGarvey was named the first-ever Illinois Special Education Teacher of the Year for 2021. Katie, congratulations on this accomplishment.

Our next "Those Who Excel" award winner is Julie Nowak, who was recognized in the School Administrator category. Julie has been the principal at James B. Conant High School for six years and has worked in District 211 for more than 25 years. She has described her career as being focused on equity, belonging, and excellence. She sees her role as one of service to students, parents, faculty, and our community. Julie has been described as a highly talented, perceptive, and encouraging instructional leader. A student at Conant High School said that Julie always takes the time to listen to everyone, regardless of the challenges she was dealing with at the moment. A fellow District 211 principal called Julie a fearless and a determined leader. When a student was looking to create a new school club to focus on diversity, she stated that Julie didn't talk to her as though she was a naïve teenager, but rather Julie was very receptive and she supported the creation of the new organization. The student went on to say that Julie was a catalyst that changed her life. Julie, congratulations on your well-deserved award and thank you for all that you do for Conant High School and District 211.

Palatine High School Mathematics Teacher and Dean of Students Joyce Richardson is our next awardee. She is being recognized in the category of Classroom Teacher. When Joyce was in high school, she said that math was one of her harder subjects. It wasn't until college that when she was tutoring a high school student in remedial math and she saw his reaction when he succeeded, Joyce knew she had found her calling. For more than two decades, Joyce has continued to strive to help her students achieve that same feeling of success. One student recalled feeling overwhelmed by her calculus class after failing a test. That student said that Joyce met with her for an extra hour almost daily, providing insight, resources, and practice materials. She said that following Joyce's help, she felt better prepared for college calculus more than any other class. Outside the classroom, Joyce has dedicated her time to help students through PHS's 'Say Yes to the Dress' program that provides students an opportunity to obtain homecoming and prom dresses regardless of financial abilities. A fellow teacher said that while she and her peers discuss daily how they can better serve students, Joyce is the one who drives the change that makes the difference. Joyce, for all you have done and continue to do for students at Palatine High School and in District 211, thank you and congratulations.

Tom Speziale, a "Those Who Excel" awardee, is not here tonight. But, I would like to recognize him because of his position in the Educational Service Personnel category. Tom's primary duty is as a teacher assistant at Fremd High School. He is the facilitator of the school's Tutoring Center and Guided Study Hall. His desire to help students reach their full potential can be seen across the school. Principal Kurt Tenopir said that Tom's proactive approach to dealing with potential issues and self-sufficient work ethic are the reasons the Tutoring Center is successful. One teacher said that Tom has helped students develop helpful testing strategies and organizational methods and Tom has been described by others as 'always being positive,' and that he is able to communicate effortlessly with students from all walks of life. This is just one example of Tom's dedication to students. When he noticed that a student was struggling, Tom worked to become a trusted adult, making himself available for the student and working with other teachers on the student's behalf. Many students refer to him as their 'school dad.' We recognize Tom tonight for all he does for Fremd High School student and District 211.

On behalf of the principals who are here this evening as well as the Board of Education, thank you all for all you do. You all certainly are an integral part of our District and you make us who we are today."

The Board of Education received and reviewed a report on the Class Size Committee.

2020-2021 School Year Update

Superintendent Small provided an update on the 2020-2021 school year, including, 49 percent of students selecting daily in-person learning and 51 percent of students selecting daily remote learning during the second semester; students were invited to attend school in-person regardless of their attendance assignment at the beginning of February; the schools ranging from 30 to 50 percent of capacity with up to 70 percent of capacity at one of the District's academies; the principals' reporting that some students who have never previously attended in-person school coming into the buildings and their interest in wanting to continue to come to school for in-person learning; the Illinois State Board of Education (ISBE) formally asking the United States Department of Education to make waivers available for required spring testing, which would have a significant effect on our juniors and seniors who would be required to participate in the SAT test in order to earn a diploma; the plan to finalize spring testing plans in March; District 211 schools holding practices and competitions for the Illinois High School Association (IHSA) winter season athletic teams with a maximum of 50 spectators being allowed and a 30-foot barrier between spectators and athletes being required under Phase 4 mitigations and either certain live-stream events or post-recorded athletic events for online viewing after the events; District 211's efforts to coordinate with District 15 and District 54 to conduct large-scale vaccination administration at one or possibly two of District 211 schools, the students with incompletes in grades from second semester being given opportunities toward credit completion; each school having unique outreach opportunities for students and offering them one-on-one connections with their teachers and faculty members who are able to help them; and the schools finalizing their options for senior student events.

Several Board members asked questions about test preparation opportunities for students for standardized testing across the District and Superintendent Small, Assistant Superintendent for Curriculum and Instruction Joshua Schumacher, and Mrs. Hummel answered Board members' questions.

District 211 Equity Team Update

Resolution Abating a Portion of the Taxes Levied for the 2020 Tax Year
