#### FY22 Budget and Five Year Financial Forecast Update

Superintendent Small introduced the presentation by stating:

"Tonight, Lauren Hummel, Chief Operating Officer and Barb Peterson, Controller and Treasurer will present the updated financial forecast to prompt the discussion surrounding a potential abatement to the levy that was approved in December and abatement of the tax recapture levy amount.

If an abatement or change to the total amount levied in December of 2021 is going to occur it must be filed with the county by March 31, 2022. If this occurs, the new amount levied by District 211 is reflected in the second installment of the 2021 tax bills.

The long-range financial planning includes: use of the land sale revenue and total budget surplus, 2021 CPI which is now determined, continuing planned capital priorities and utilization of funding for additional capital projects including student auditoriums, PA systems and HVAC improvements to Applied Technology, waiver of student fees and updated revenue and expenses for FY22.

These factors are all a part of tonight's projections and portray the level of risk taken in future years for maintaining fund balances for long-term, debt-free financial stability for current and future students."

The motion carried 5-1.
