## **Placement Testing of Incoming Freshmen**

We begin course selections for all our students in the upcoming weeks as the choices of our students drive our master schedule development and ultimately our staffing needs. This process includes our current teachers, our student services departments, and many other staff members who help our students and families transition to their next new year in high school."

# **Illinois Association of School Boards Resolutions 2021**

The Board of Education received, reviewed, and discussed the proposed Illinois Association of School Board (IASB) resolutions that were submitted by IASB member districts and the IASB Resolution Committee's recommendations regarding the resolutions.

Mr. Rosenblum, who will represent District 211 as the voting voice for the Board of Education at the upcoming virtual Delegate Assembly of the IASB, gave an overview of his role at the Delegate Assembly at which he will vote on behalf of the majority of the Board; and he stated that the Board was provided the list of the IASB resolution items for their review and for discussion at tonight's meeting. Mr. Rosenblum stated that he will poll the Board members to see if they are in favor of the resolution or if they are not in favor of the resolution so that he can vote on behalf of the majority of the Board.

Mr. Rosenblum asked if there was consensus to support IASB Resolution 2 – Gun Storage that states, "BE IT RESOLVED THAT the Illinois Association of School Boards shall support and advocate for legislation which provides local school boards the option of developing Student Safety and Protection Plans legislation which allow voluntary district employees, in any capacity, the ability to carry a concealed firearm on district property, provided the employee has a valid Illinois Firearm Owners Identification (FOID) card, holds a certified Illinois Concealed Carry License, and has completed all additional trainings and certifications set forth by the respective school board, one of which must include yearly certified active shooter training. Only district employees who fulfill all requirements listed and receive superintendent and board approval would be eligible as an active and armed part of the Student Safety and Protection Plan."

The following Board members made statements about the District's membership in the IASB and the Board's discussions of the proposed IASB resolutions: Mr. Dombrowski and Mr. Cramer.

After discussion, commenting to oppose IASB Resolution 2 were Ms. Cavill, Mr. Mc Gowan, Mr. Bradley, and Mr. Rosenblum. Commenting to abstain from the polling were Mr. Dombrowski, Mr. Cramer, and Mrs. Klimkowicz.

Mr. Rosenblum asked if there was consensus to support IASB Resolution 15 – Child Safe Gun Storage that states, "BE IT RESOLVED THAT the Illinois Association of School Boards shall support and advocate for legislation which strengthens child safe gun storage laws in the state of Illinois requiring gun owners to store firearms, whether they are loaded or unloaded, in a securely locked container, if a person under the age of 18 is likely to gain access to the weapon without permission."

The Board discussed IASB Resolution 15. Commenting to support IASB Resolution 15 were: Mr. Bradley, Mr. Rosenblum, Ms. Cavill, and Mr. Mc Gowen. Commenting to oppose Resolution 15 was Mrs. Klimkowicz. Commenting to abstain from the polling were Mr. Cramer and Mr. Dombrowski.

Mr. Rosenblum asked if there was consensus to support IASB Resolution 10 – Cannabis Sales that states, "BE IT RESOLVED THAT the Illinois Association of School Boards shall introduce and support legislation that would allocate 20% of state tax revenues from cannabis sales to public education programs that support youth development, violence prevention, and health education. These funds shall be divided equitably across the state based on the Disproportionately Impacted Area (DIA) maps that determine the R3 funding."

After discussion, commenting to support IASB Resolution 10 were Mr. Bradley, Ms. Cavill, Mr. Mc Gowan. Commenting to oppose IASB Resolution 10 were Mr. Rosenblum and Mrs. Klimkowicz. Commenting to abstain from the polling were Mr. Cramer and Mr. Dombrowski.

Mr. Rosenblum asked if there was consensus to support IASB Resolution 4 – Board Member Childcare Reimbursement that states, "BE IT RESOLVED THAT the Illinois Association of School Boards shall support and advocate for legislation that allows for board members to be reimbursed for childcare costs as a result of participation in board meetings. Removing barriers to increase access and participation of potential board members is core to the mission of the IASB."

These may include, but not limited to, rain gardens, pollinator gardens, stormwater detention areas, trees and perennial plants whose root structure can help soil erosion, and sidewalks, bike paths, and covered bike parking to encourage students and staff to use active transportation to get to school."

After discussion, commenting to oppose IASB Resolution 13 were Mr. Bradley, Ms. Cavill, Mr. Rosenblum, Mrs. Klimkowicz, and Mr. Mc Gowan. Commenting to abstain from the polling were Mr. Cramer and Mr. Dombrowski.

Mr. Rosenblum asked if there was consensus to support IASB Resolution 5 – Remote-Virtual School Board Open Meetings that states, "BE IT RESOLVED THAT the Illinois Association of School Boards shall urge the Illinois General Assembly to pass legislation to allow school boards, and committees of school boards, subject to the Illinois Open Meetings Act (105 ILCS 120/7) to allow open or closed meetings to be conducted via audio or video conference, without the physical presence of a quorum of the members, so long as provisions are included: addressing verification of members present with full access and participation in the meeting; providing that public members attending in person at the location can observe all votes and discussion of the body; providing certain personnel are present at the posted meeting location; addressing the process for how votes are conducted to guarantee identification and proper recording; providing appropriate notice to news media and public regarding time, location, and methods of participation; providing appropriate verbatim record and recording of meetings are maintained and provided to the public; to remove restricting remote participation to only times of personal illness, disability, employment purposes, or family emergency."

After discussion, commenting to oppose IASB Resolution 5 were Mrs. Klimkowicz, Mr. Rosenblum, Ms. Cavill, Mr. Bradley, and Mr. Mc Gowan. Commenting to abstain from the polling were Mr. Cramer and Mr. Dombrowski.

Mr. Rosenblum asked if there was consensus to support IASB Resolution 9 – Health and Sex Education Curriculum that states, "BE IT RESOLVED THAT the Illinois Association of School Boards shall support and advocate for local school district control of content and curriculum for health and sex education courses offered in their districts."

Mr. Rosenblum asked if there was consensus to support IASB Resolution 12 – Electric School Buses/Charging Stations Federal Funding that states, "BE IT RESOLVED THAT the Illinois Association of School Boards shall urge the Congress of the United States to provide federal funding to school districts for clean electric school buses and charging stations."

After discussion, commenting to oppose IASB Resolution 12 were Mr. Rosenblum, Mr. Bradley, Mrs. Klimkowicz, Ms. Cavill, and Mr. Mc Gowan. Commenting to abstain from the polling were Mr. Cramer and Mr. Dombrowski.

Mr. Rosenblum asked if there was consensus to support IASB Resolution 1 – Pre-Service Teacher Education and Licensure in Literacy" that states, "BE IT RESOLVED THAT the Illinois Association of School Boards shall advocate for legislation mandating the Illinois State Board of Education require pre-service teachers seeking licensure in the areas listed complete at least one undergraduate level literacy education course solely dedicated to scientifically proven methods of reading instruction. Before being granted licensure in the following areas, individuals must receive a passing score on the most recently published Foundations of Reading Exam using cut scores in the formal standard setting process. Licensure areas that should meet these requirements are: Early Childhood Education, Early Childhood Special Education, Elementary Education, English Language Arts, Middle Grades Language Arts, Reading Specialist, Reading Teacher, Special Education, Speech Language Pathologist, and English Language Learner Teachers."

After discussion, commenting to support IASB Resolution 1 were: Mrs. Klimkowicz, Mr. Bradley, Ms. Cavill, and Mr. Mc Gowan. Commenting to oppose IASB Resolution 1 was Mr. Rosenblum. Commenting to abstain from the polling were Mr. Cramer and Mr. Dombrowski.

President Klimkowicz thanked Mr. Rosenblum for preparing and leading the discussion on the IASB resolutions and she thanked the Board members for participating in the discussion on them.
