President Klimkowicz led the Board of Education and the audience in the Pledge of Allegiance.

Student Support Services Panel

Superintendent Small made the following statement:

"It is my pleasure to introduce a group of people who work from different perspectives to achieve the same goal of providing for the needs of our students and their families.

Jacquese Gilbert is the director of summer school and community outreach. In one of her roles, she connects with many of our outside service providers for our families through the Partners for Our Community.

Dr. Mary Pat Krones is the assistant director of special education, a psychologist and is on the Board of Directors for The Bridge Youth and Family Services.

Matt Hildebrand is the director of administrative services and works with our intervention offices, school resource officers and is the homeless liaison for the District.

Mike Alther is the facilitator this morning and is the Principal of Hoffman Estates High School.

We also have an additional guest, Officer Christina Gibbs, who is the school resource officer at Schaumburg High School and also present is Officer Rich Rebmann, school resource officer, Hoffman Estates High School.

Our students attend school for their education, but to fully access these educational opportunities to their fullest, they may need support services for themselves or their family along the way. Today, for a few minutes we will give a brief introduction to our student support services. I truly appreciate all of you being here today. We have a limited time of 15 minutes for this panel discussion, so we will get started."

The panelists presented on various student support services.

Responses to Pre-submitted and Written Questions

The Board of Education members, panelists and Superintendent Lisa Small answered pre-submitted and written questions on student support services and general questions regarding mask wearing, not using phones in school, legal fees for a current lawsuit, Spanish-speaking parents' transitions to high school and parent groups, tools already available for career exploration and parents on the District Wellness Committee.
