Recognition – Admiral Thomas B. Hayward Leadership and Learning Award

Superintendent Robb introduced Palatine High School Assistive Technology Coordinator Alison West and Teacher Assistant Valerie Okrasinski.

We have two special staff members with us tonight who have been selected as recipients of the Admiral Thomas B. Hayward Leadership and Learning Award which is given to educators who demonstrate leadership and innovation, and are instrumental in improving student performance. They will be recognized and receive their awards at a ceremony in December in Washington D.C. at the Superintendents' Summit.

Alison West is the assistive technology coordinator for District 211 and Valerie Okrasinski is a teacher assistant in the physically-challenged program at Palatine High School. Together, they developed a unique program in which students with physical challenges create digitized curriculum material for students with other disabilities. Students with autism and other disabilities sometimes need access to digital materials in lieu of print materials. Alison and Val recognized that students in the physically challenged program could have a valuable work experience while at the same time provide students the materials they need. Alison and Val trained students in the program to scan, edit, and reproduce files, creating a digitized library of the District's textbooks and novels. The result was a win-win experience for students who needed a vocational experience and those who needed access to digitized materials.

There also is a \$2,000 prize awarded to the District on behalf of Alison and Valerie's recognition, which will be used to support the District's ever-growing assistive technology supply needs.

Principal Lisa Small refers to Beth as the "mother hen" of the Viking Tutoring Center, the person who protects, pushes, and watches over students who are struggling academically, and many times personally. She genuinely cares about her students, and offers them a support system they can count on at a difficult time in their lives. Under her nurturing care, many students have gone on to successes they hadn't imagined.

We are proud to have Beth in our district, and congratulate her on this honor.

Special Education Teacher Camille Lutz is known for helping others reach their potential, both students and staff. She has a passion for literacy – and the skills to share that passion. She's also an exceptional classroom teacher, who according to Conant Principal Tim Cannon, "changes the lives of all she comes in contact with. Camille has positively impacted thousands of students who would have gone unnoticed at our school." As one parent of a student with Asperger's Syndrome put it: "I'm truly in awe of the scope of her effectiveness."

Fremd High School Principal **Lisa Small** was recognized with a "Those Who Excel" award in the School Administrator category.

Although Dr. Small is principal at Fremd High School, she has never stopped teaching – not only students, but faculty and support staff as well. She has taught workshops to train student supervisors on strategies to defuse potentially disruptive situations; she recently taught an in-district class for teachers on differentiation; and she fully supports programs such as the school's Viking Advisory Mentoring Program for incoming freshman, assisting students in their high school transition. As one student said: "She has made Fremd High School a home for students, and a welcoming place for parents, faculty, and community members."

The Commit to the Pirate team, after 8 months of training, shared their expertise with the entire PHS staff, including teaching expectations, acknowledging positive behaviors, and utilization of a concise discipline process. The result of their program is new school spirit and sense of pride, a decrease in the number of discipline referrals, an increase in attendance, and an overall change in the climate of the building, all with the goal of increased student success.
