## **Board of Education Recap**

The Township High School District 211 Board of Education met on Thursday, April 28, 2022, in the Board Room of the G.A. McElroy Administration Center. The following is a recap of items that were acted upon at the meeting.

### **Administrative Appointment**

The Board of Education approved the appointment of LaShaunda Sandifer as the District's Director of Diversity, Equity and Inclusion. She currently is a special education teacher at Glenbard West High School, a position she has held since the 2020-2021 school year.

She began her teaching career in 2013 as a paraprofessional in Thornton Fractional Township District 215 and transitioned into special education one year later. She also has held a special education teaching role at Homewood-Flossmoor Community School District 233.

Ms. Sandifer received her undergraduate degree in Criminal Justice from Wright State University and holds a master's degree in teaching from National Louis University and a master's degree in Educational Leadership from Wright State University. She earned a Diversity and Inclusion Certificate from Cornell University and is scheduled to complete her Director of Special Education Certificate in August 2022.

## **Ratification of Master Contract with Teachers' Union**

The Board approved a two-year contract with the District 211 Teachers' Union.

The contract, which takes effect July 1, 2022, is a two-year agreement. It provides for 3 percent base salary increases for each of the two years and also aligns final pre-retirement earning limitations at a 6 percent threshold consistent with an Illinois legislation change. The contract also calls for increased health care premiums.

## **Strategic Plan: Mission and Values**

During the Strategic Plan Workshop at the Special Board of Education Meeting on April 14, Board members evaluated District 211's mission and values statements with the guidance of a consultant from Insight Education. Board members provided individual and collective input into reshaping the mission and values at that meeting.

The Board reviewed proposed mission and value statements, and both will be brought back to Board meetings on May 12, 2022 and May 26, 2022 for official review of the changes and subsequent approval.

## **Request for Proposal - Athletic Training Services**

District 211 provides comprehensive athletic training services at each of our high schools. Athletic trainers provide assistance to all levels of the District's 30 sports including practices, contests, summer camps and special events.

District 211 employs a full-time staff member as a head athletic trainer at four high schools and has a stipend position for head training responsibilities at James B. Conant High School. To support the remaining athletic training needs at each school, the District has contracted with area athletic training service providers on an annual basis.

The District's current contract for athletic trainer services is with Athletico Physical Therapy. The current two-year agreement expires June 30, 2022. A new Request for Proposal was sent to seven vendors. Athletico was the only vendor to reply to the request.

The Board reviewed a recommendation to enter into a three-year contract with Athletico Physical Therapy for the period July 1, 2022 to June 30, 2025 with an option for a two-year extension for the period July 1, 2025 to June 30, 2027.
