A regular meeting of the Board of Education, Township High School District 211, Cook County, Illinois was held on January 18, 2018 at 7:30 p.m. in the G. A. McElroy Administration Center at 1750 South Roselle Road, Palatine, Illinois.

Pledge of Allegiance

President Burke led the Board of Education and the audience in the Pledge of Allegiance.

Citizens' Petitions and Appearances

President Burke asked if there was anyone present who is not on the agenda or who did not sign in on the speaker sign-in sheets and would like to address the Board of Education.

Ralph Bonatz addressed the Board regarding statements he made at their December 14, 2017 meeting; his full and corrected statement from that meeting that he provided the Board and the Superintendent; his apology to the Board for running over his allotted time at that meeting and his understanding that the rules governing their proceedings are placed for good reasons; a female student's concern that her gym grade could be affected by her not changing clothes in the locker room in the presence of students who were born male; and a student's concern about elected officials letting the rights of a minority outweigh the needs and pleas of the majority.

Jennifer Zold addressed the Board thanking them for their time and service and regarding statements from District 211 students, whose names she withheld for their privacy, about their concerns about sharing a locker room and bathroom with transgender students who have a different biological sex, and the Board’s responsibility to respect all students’ rights.

Joseph Qian addressed the Board regarding comments that were gathered from District 211 females, whose names he withheld for privacy, involving their concerns about sharing the locker room and bathroom with transgender students of a different biological sex and students’ right to privacy.

Teri Paulson addressed the Board regarding statements from District 211 students, whose names she withheld for privacy, involving their concerns about sharing the locker room and bathroom with transgender students of a different biological sex, students’ right to privacy, and having separate changing rooms according to students’ anatomy.

Beth Kalopisis addressed the Board regarding concerns from District 211 students, whose names she withheld for privacy, about a transgender student she claimed violated the policy of changing clothes in the privacy area, sharing a locker room with someone who has different anatomy, and biological boys being given access to the girls’ locker room; and her comments about protecting the dignity, modesty, and well-being of minor children and all students’ voices mattering.

Justine Janosko addressed the Board regarding statistics about transgender people not physically harming anyone and transgender people’s suicide attempts, transgender people enduring anxiety and public scrutiny, the process for District 211 transgender students being given access to the locker room of their preference, and her thankfulness for the humanity District 211 has shown her.

Presentation: Every Student Succeeds Act (ESSA)

Superintendent Cates introduced Associate Superintendent for Instruction Lisa Small. Dr. Small introduced Associate Superintendent for Student Services Mark Kovack, Director of Summer School and Community Outreach Jerry Treviño, Director of Instructional Improvement Danielle Hauser, and Director of Administrative Services Matthew Hildebrand. Dr. Small, Mr. Kovack, Mr. Treviño, Dr. Hauser, and Mr. Hildebrand presented information and answered Board members’ questions on District 211’s detailed accountability system for the Every Student Succeeds Act (ESSA) – the nation’s education law and commitment to equal opportunity for all students – to ensure the opportunities for all District 211 students.
