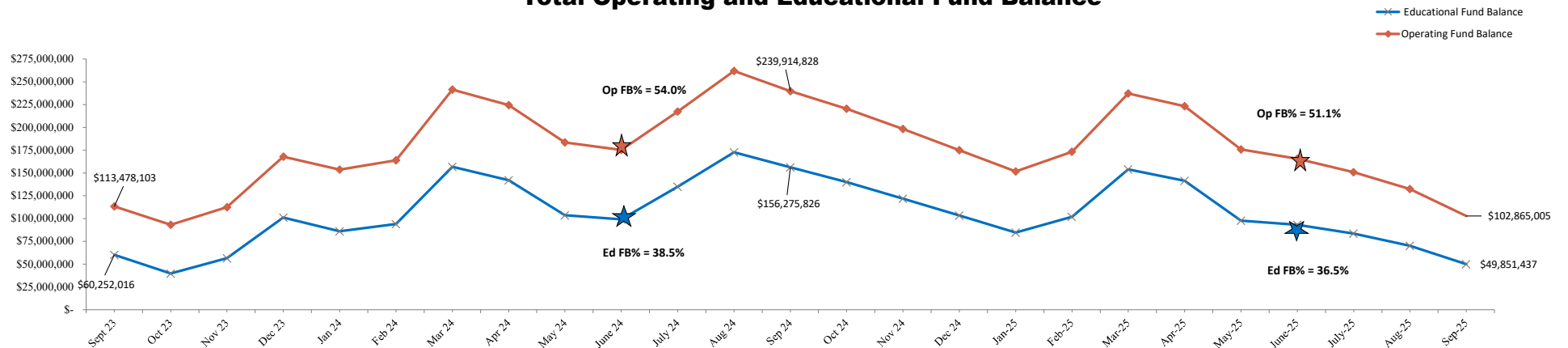

Total Operating and Educational Fund Balance*

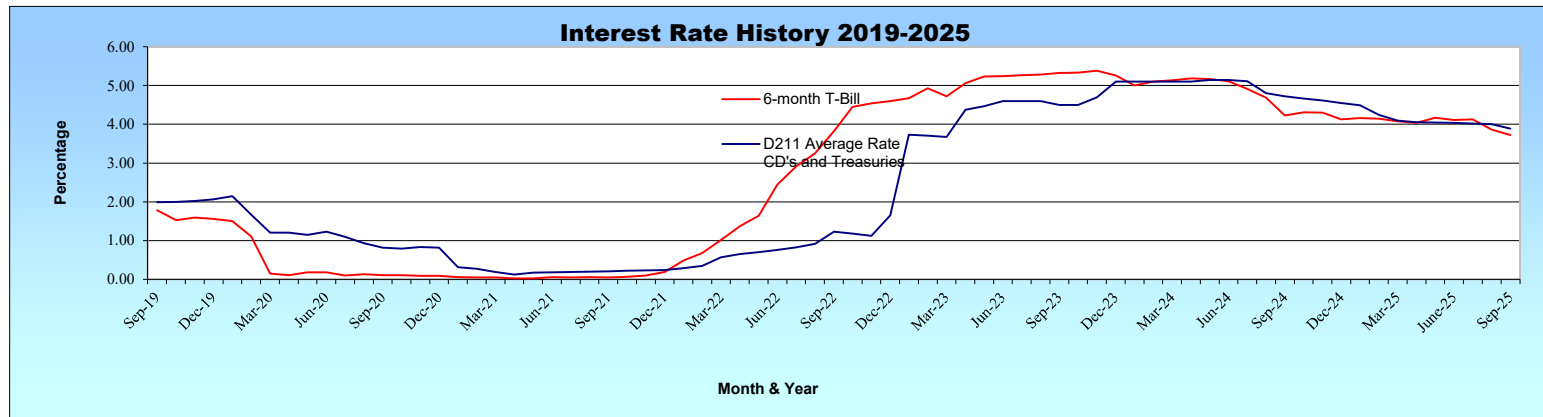
