## REGISTRATION INFORMATION HIGGINS EDUCATION CENTER 2017-2018

Welcome to the 2017-2018 school year. The first day of classes will be **Monday, August 14, 2017.**

Township High School District 211 uses an online registration and fee payment system. You may complete your registration at home or at any location where you have internet access. In mid-June, you will receive an invoice that will assist you with registration. Online registration will begin on Saturday, July 1, 2017. You will be able to complete online registration by logging into your ***Infinite Campus Parent Portal***; this link is available on the District 211 website. Online payments will be accepted using a credit or debit card (MasterCard, Discover, or Visa) through Sunday, August 6, 2017. If you do not have access to a computer or if you prefer to pay using cash, check, or money order, completed registration forms and fee payments may be delivered or mailed to: Township High School District 211, 1750 South Roselle Road, Palatine, IL 60067. Fee payments should be made payable to **Township High School District 211.**

To verify the accuracy of current student information, please review and update the Enrollment Information enclosed. You may submit changes to the form through your Infinite Campus Parent Portal. If returning the form by mail, the form must be signed. If any changes in guardianship have occurred, supporting documentation will be required. Documents should be submitted to Debra Duffy, at the G.A. McElroy Administration Center; if you have any questions, please contact Ms. Duffy at (847) 755-6637.

The registration fee for the 2017-2018 school year is \$170 per student. Information regarding the National School Lunch and Breakfast program will be mailed home to each family in late July.

**Reminder to all Freshmen and New Students:** You must submit a current physical, appropriate immunization records, proof of residency, and original birth certificate in addition to paying registration fees for the 2017-2018 school year in order for your enrollment to be complete.

You will be notified of transportation information in August.

Freshmen and students new to the Higgins Education Center will be able to pick up their iPads during the first week of school. All students must be fully registered, including the payment of school fees prior to picking up their school-issued iPad. Receipt of a school-issued iPad may be delayed if a student is not fully registered by Saturday, August 5.
